T1 Lime (Tilia x europa) Reduce by 3-4m back to most previous reduction points, retaining some furnishing growth. Final height 12m and spread 7m.	
REAR GARDEN	
T2 Bay (Laurus nobilis) Reduce by around 30%, removing 2-3m of new growth. Final height = 4m and final spread = 3m.
