REAR GARDEN: 1 x Sorbus (T1) - Reduce any over long branches back into main crown structure up to 50cm. Thin crown density evenly throughout by 15% - 20%.

- 1 x Birch (T3) Thin crown density by approx. 20%. Reduce overlong extraneous branches back into main crown structure up to approx. 1m.
- 1 x Malus (Crab Apple) (T4) Thin crown density by 20% 25%. Reduce overlong extraneous branches back into main crown structure, approx. 1m.
- 2 x Maples (T5 & T6) Tip prune overlong branches by up to 50%. Lightly thin crown density by 15%.
- 1 x Sycamore (T7) Reduce back to previous and most recent points of reduction, approx. 1.2m. Thin crown density by 20%.
- 1 x Prunus (T8) Thin crown density by approx. 20%. Tip prune to reduce by up to 1m.

The Council has considered your notification of intended works to trees dated 22 January 2025 and does not wish to object.
