Front boundary treatment It is proposed to replace the existing boarded timber fence at the front of the property with metal railings raised on a brick dwarf wall and brick pillars. Currently, the two halves of this substantial semi-detached pair of houses share the same fence treatment as can be found at No 13, and No 7 as the other half of the pair is not subject of the proposed boundary alterations. There appears as a whole to be a mix of front boundary treatments in Wedderburn Road, with some properties having low red brick walls and others timber fences, and some with hedges. The submission does not contain an historic evidence-based analysis of the original front boundary treatments to Nos 7 and 9, so it is not possible to make an informed assessment of the proposed new wall and railings. However, other than in front of Belsize Court, a mansion block at the junction with Lyndhurst Gardens (a different residential building type warranting a different boundary treatment to the houses), metal railings are not characteristic of the streetscape in Wedderburn Road. To remove the boarded fence will also detract from the uniformity that currently exists at the front of the two properties. Further research is therefore required to justify the removal of the fence and its replacement as currently proposed. Bin store Drawings plus photographs of examples of bin and bike stores have been submitted. However, they are not specifically tailored to the site other than on the site plan which shows them located directly behind the proposed new boundary treatment. Whilst it is not possible to make a full assessment of their impacts at the current time, it is likely that the location will be acceptable subject to their visibility from the street, which will depend on their height, section (bulk and mass), materiality (timber is likely to be acceptable), and how they sit adjacent to the front boundary treatment.
