Our Client would like to reduce 2x Cypress Leylandii trees and remove to ground level 1x Small self set sycamore on the rear boundary of their garden

- T1 larger Cypress Leylandii tree on the left in attached photo, reduce by up to 3m in height and reduce 1m lateral overhang, to suitable growth points.
- T2 smaller Cypress Leylandii tree on right hand side) reduce by up to 1m in height and reduce lateral overhang by up to 1m to suitable growth points.
- T3 young self set Sycamore tree, this tree is growing through T1 and is requested to be removed to ground level.

The of reasons for this application is to manage the size of the trees in relation to the space at the bottom of the garden to elevate the trees creating excessive shade. As well, all three trees are also growing into the canopy's of the larger Ash trees (in front and to the side as seen in the photo) and they would like to keep them separate so they don't interfere with one-another and can in future maintain the leylandii's as a boundary and privacy screen.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
