T1 and T2 - Wild cherrys at the front of the property. Both to be target pruned back away from building and from entrance to underground car.

T1 to be pruned back on west side by approx 1m.

T2 to be pruned back on south side by approx. 1m.

T3 Lime - Two wounds at the base on north and south side. Currently 15.5m Tall. Repollard and reduce top by approx 5m due to the two wounds in the base of the tree and the building being approx 11m from the base of the tree. This should mean if the tree were to fail round the wounds it is unlikely to hit the building and casue any damage to the building or garden furniture.

T4 Lime - Re-pollard.

T5 Sycamore - Re-polallard and remove large deadwood.

T6 - Wild Cherry. Root flare is compromised. Wound at 2m on stem. Large lean to the east towards car park to the west. Reduce top/east back by approx 1.5m to prevent it striking anything in the car park and remove deadwood. This would leave the east side of the crown at approx. 3m.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o mark and name surrounding roads
 - o sketch in buildings, including adjoining properties
 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
