Proposed Work:

FRONT GARDEN: 1 x Cherry (T1) - Reduce by 1m - 2m approx. lateral and vertical growth and thin by 10%.

REAR GARDEN: 1 x Eucalyptus (T2) - Reduce by 1m approx. lateral and vertical new growth.  
2 x Malus (G3) - Clip by 1m and tidy.

1 x Weeping Silver Birch (T4) - Clip by 0.5m back to previous points to clear building and shape.

The Council has considered your notification of intended works to trees dated 22 January 2025 and does not wish to object.

Informative(s):

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
