T1) Horse chestnut - Reduce crown by 50% 4 m of height and 2.5 m of width, removing 3 limbs with root decay right down to the crown break, We did this tree a few months ago reducing it back to its previous growth point and noticed that there is a lot of rotten cankers and splits in a lot of the branches and limbs I think it would be a safe idea before it grows back in a few years to reduce the tree significantly for the health and safety of the public as this tree is located over the main route into Hampstead and overhangs the road and pavement, I've discussed in with my client that it is not an issue now but when the tree grows back and if there is any heavy winds this is going to be a danger so I just want to get the clearance on doing this so we can it within the next two years and also if a site inspection is needed to do it in the winter months before it comes back into life as you're not going to be able to see clearly the tree comes into leaf.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
