The outdoor seating area will be managed by trained Happy Bones Coffee staff during operational hours.

Staff will ensure that tables, chairs, and barriers are arranged as per the approved layout to prevent obstruction of pedestrian access.

The area will be checked every 30 minutes and cleaned to maintain hygiene.

Tables and chairs will be removed and stored indoors at the end of each trading day.

The layout of the outdoor seating ensures a clear line of sight from inside the coffee shop, allowing staff to effectively monitor and manage the tables and chairs while maintaining a safe and inviting atmosphere for customers.
