T22 Conifer - Cut back from building to suitable growth points, approx. 2-3m. - Reduce height by 2-3m. - Reduce remaining crown to balance, approx. 1.5m to be pruned laterally.
<ul> <li>G1 Lime x 3 (T23-T24-T26)</li> <li>These trees are not listed on the tree report supplied.</li> <li>Reduce all aspects of the crowns back to previous points of reduction, approx. 3-4m.</li> <li>Sever Ivy at ground level.</li> </ul>
T40-T41 Holly x 2 - Cut back from the main car park to create 2m clearance. - Reduce remaining trees by approx. 2-3m.
G2 - London Plane x 4 (T25-T27-T28-T29) - Reduce all aspects of the crowns by approx. 2-3m to create a tight and tidy shape. - Cut back T29 from Building
T30 Alder - Reduce all aspects of the crown by approx. 2-3m to create a tight and tidy shape.
T12-T13-T14 Common Lime - Crown lift to provide 3m clearance from ground level.
T15 Tree of Heaven - Reduce all aspects of the crown by approx. 1-1.5m to create a tight and tidy shape. - Remove dead wood.
T31 Sycamore This tree is not not listed on the Tree Report supplied. - Reduce all aspects of the crown back to previous points of reduction by approx. 2-3m.
T32 London Plane (opposite No.18) This tree is not listed on the Tree Report supplied. - Reduce all aspects of the crown back to previous points of reduction by approx. 3-4m.
T16 Common Horse Chestnut Please see Tree Report. - Sever Ivy at ground level.
G17 Leyland Cypress Please see Tree Report G18 Indian Chestnut, Elder Please see Tree Report G19 - Indian Horse Chestnut
T21 Cappadocian Maple Located on the southern side of the football pitch. - Crown reduction to maintain clearance to building

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - $\circ\;$  marking all trees on the plan, but only numbering those to which you want to carry out work
  - $\circ~$  showing the approximate distance between the application tree(s) and buildings
  - $\circ\;$  adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
