1 x Purple Plum - Reduce the crown height by 33%
Lightly reduce the crown spread to shape
The trunk is decayed due to large historic wounds

1 x Purple Plum - Thin throughout the crown by 15%
Reduce the crown spread by 0.6-1m

4 x Birch - Lightly reduce the horizontal branches by up to 1m and to a height of 4m from ground level

Maintenance works in line with good Arboricultural practice
