Sycamore aged c. 70 years, height c. 15 metres, crown spread 10 metres. The tree leans over Cannon Lane, and has a structurally poor root system close to the two-metre-high retaining wall along the northerly side of Cannon Lane
Proposed work: remove ivy from tree; crown reduce by 30%; and ensure four metres of clearance from roof of house on far side of Cannon

Reasons: the tree is potentially dangerous and is a cause of concern for the resident of the house on the far side of Cannon Lane

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
