REAR GARDEN: 1 x Holm Oak (Quercus ilex) (T3) - Crown reduce height by 2m from branch tips. Reduce laterals by 1m from branch tips to reshape.

- 1 x Holly Gentle (Ilex aquifolium) (T4) Crown reduce by no more than 0.8m all-round from branch tips.
- 1 x Holm Oak (Quercus ilex) (T5) Crown reduce height by 2m. Reduce lateral growth by up to 1m.
- 1 x Yew (Taxaus baccata) (T6) Crown reduce all by 1m from branch tips all round to rebalance and shape tree.
- 1 x Sycamore (Acer psuedoplatanus( (T7) Crown thin by 25%.
- 1 x Holly (Ilex aquifolium) (T8) Crown reduce height by 1.5m. Reduce laterals by 1m and 1.5m on north face to balance.

The Council has considered your notification of intended works to trees dated 27 January 2025 and does not wish to object.
