The Council has considered your application and decided to grant permission subject to the following condition(s):

# Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

The development hereby permitted shall be carried out in accordance with the following approved plans: PL-001ND; PL-002ND; PL-003ND; PL-004ND; PL-005ND; PL-006ND; PL-008ND; PL-009ND; PL-010ND; Design and Access

Statement received on 15th January 2025 (x 1 page).

Reason: For the avoidance of doubt and in the interest of proper planning.

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies D1 and D2 of the London Borough of Camden Local Plan 2017.

# Informative(s):

1 Reasons for granting permission.

The property is a four storey detached late Victorian brick house forming a pair (with No. 3) of detached buildings. It is a positive contributor in the Hampstead Conservation Area Appraisal where both Nos 3 and 5 are described as "detached houses with two storey double bays on the front elevation, an unusual pair".

The proposal involves the replacement of an existing window with an external door on the lower ground floor side elevation in order to allow the applicant to create a new access to secure bike storage. The proposed 3-panel door would be made out of solid wood. The lintel would be replaced with a new terracotta clay brick lintel to match the existing one.

The proposed door is acceptable in terms of material, location and design. It would be sympathetic to and in keeping with the existing appearance of the host property in terms of the design, locations, proportions and materials, and would preserve the character and appearance of the building and Hampstead Conservation Area in which the property is located.

The use of suitably designed timber door is considered to be an appropriate and sympathetic change which would preserve the character and appearance of the host building.

The proposed door would not be seen from the street due to its location at the back of the service alley, behind the entrance stair and would have minimal impact to the streetscape and the wider conservation area. Furthermore, owing to its location, the proposals would not cause harm in terms of overlooking.

The site's planning and appeals history has been taken into account when coming to this decision. No objections have been received following statutory consultation. A comment was received from a neighbour in relation to the two air source heat pumps that were granted planning permission on 13th August 2024 as part of 2024/2656/P. This has been addressed separately in the consultation summary.

Special attention has been paid to the desirability of preserving or enhancing

the character or appearance of the Hampstead Conservation Area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act [ERR] 2013.

As such, the proposal is in general accordance with policies A1, CC1, D1 and D2 of the Camden Local Plan 2017, policies DH1 and DH2 of the Hampstead Neighbourhood Plan 2018. The proposed development also accords with the London Plan 2021; and the provisions of the National Planning Policy Framework 2024.

- Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings.
