

PROPOSED LEGEND

1. New metal parapet coping, profile similar to existing concrete cornicing.

2. New bespoke curved metal fins fixed to window mullions.

3. Floor to ceiling glazing with concealed frame.

4. New fixed timber seating arrangement built upon existing northlight using lightweight timber structure.

5. Existing metal handrail extended to ensure Part K compliance. Refer to drawing A6020.

6. North light removed and infilled with metal deck.

7. New metal parapet screen to conceal extended lift shaft.

8. New metal planters, with feature lighting. Colour and finish to be confirmed.
9. New pivot door system.

10. Existing staircore extended to 5th floor.

11. External raised access floor system with large format tile and escape lighting built into floor.

12. Existing Northlight cleaned, made good and painted to match existing.

13. New wall mounted climber.

14. Painted timber cladding system.

15. New window opening made in existing concrete structure.

16. New skylight.

17. Internal FFL to match external FFL for level access between internal and external spaces.

18. Disabled Refuge call point.
19. New door opening to existing structure.

20. New metal acoustic screen, colour and finish to match pavilion.

21. Skylight to new structure.

22. Existing lift shaft converted to firefighting lift and extended to 5th floor.

23. Existing dry riser extended up to 5th floor.

24. New push release fire door.

25. Trellis planting.

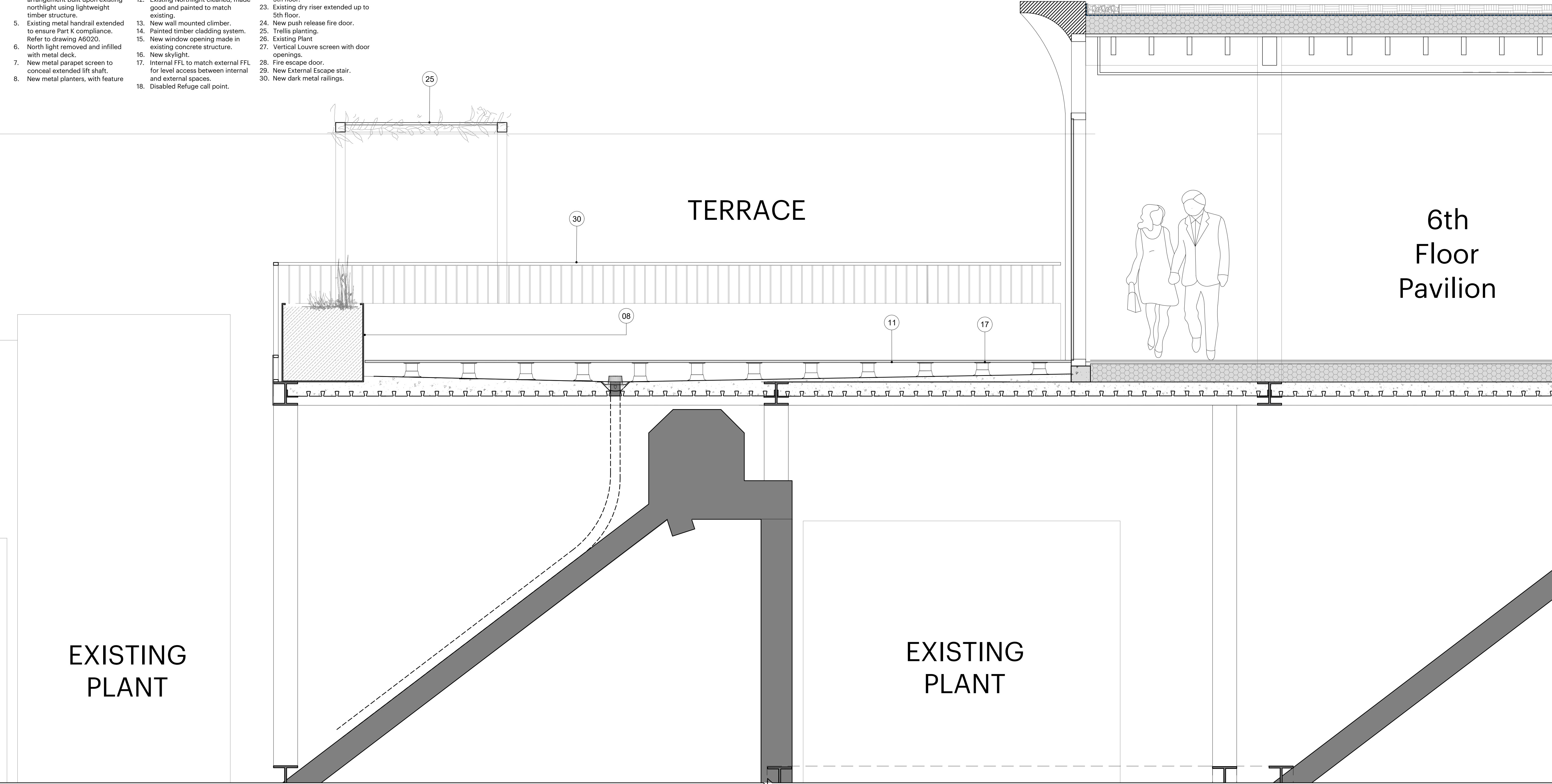

29. New External Escape stair.

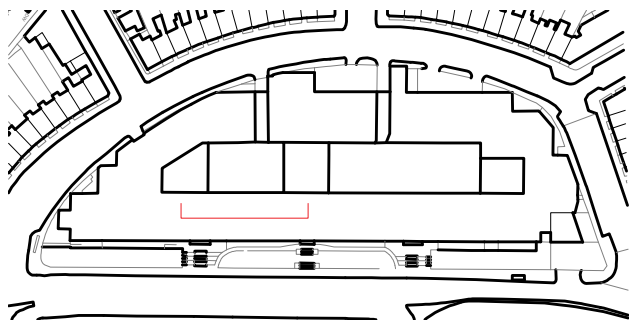
30. New dark metal railings.
