#### 1. DESIGNANDHERITAGEISSUES

The pre-application follows the recent refusal on site for the erection of a roof extension. This new design matches the neighbouring structure at number 33 in both design and scale. Because of this the scale and design are considered acceptable and ensures the extension has not just a relatively low impact on the listed building but also surrounding conservation area and neighbouring listed buildings.

The proposal appears unlikely to be visible from surrounding public views. Given the presence of the existing structures and extent of existing decking in this roofscape, it is considered that the proposed structure will not cause additional harm.

No demolition of historic fabric would be required, with the existing aperture being re-used, which is supported. The use of render to clad the extension is also supported however, the roof of the new structure should be of a traditional metal material.

The roof itself is already in use as a roof terrace and the proposal appears unlikely to increase the prominence or intensity of this use. Discussions on site confirmed the applicant was interested in in replacing the timber decking which, in principle, is supported providing the replacement is similar and has a low impact.

Overall the proposal is acceptable from a design and heritage perspective and complies with D1 and D2 of the Local Plan.

2. NEIGHBOURINGAMENITY

Policy A1 seeks to protect the amenity of Camden's residents by ensuring the impact of development is fully considered. It seeks to ensure that development protects the quality of life of occupiers and neighbours by only granting permission for development that would not harm the amenity of neighbouring residents. This includes privacy, outlook and implications on daylight and sunlight. This is supported by the CPG Amenity.

In terms of amenity, to the front the extension would not impact any amenities as this continues the existing arrangement. Because the building follows a similar scale of the building at no. 33 there would be no impact on this side and because of the end of terrace nature and lack of visibility there would be no impact to the other side either. It is not considered that neighbouring properties would be unduly affected due to noise.

Therefore the proposal complies with policy A1 of the 2017 Camden Local Plan and the Amenity CPG.

#### 3. CONCLUSION

It is considered the roof extension on the property is acceptable providing the use of acceptable materials.
