We request full removal of the T2 Elder and T3 Lilac to ground level with treatment of the stumps, as per the arborist report. The vegetation is causing subsidence damage to the homeowners property and removal of the vegetation will mitigate the issue and allow stability to be restored.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - adding other relevant features on the site (e.g. greenhouse, paths)
