T1 - Sycamore or similar, situated in the front forecourt, crown reduce by approximately 2.0m in height and 1.5m in spread.

Also lift the lower section of the canopy by 2.0m to allow more light into the flats and continue the ongoing maintenance of the tree.

T2 - Large Mature Ash tree situated at the back of the rear garden, crown reduce back to the most recent previous points of reduction. This tree looks like it has not been maintained in 4-7 years. The regrowth is substantial, and the canopy spans over multiple gardens and a shared alley way.

It is in the interest of health and safety to reduce this tree before branches start to fail.

- T3 Apple tree situated in the rear garden, in front of T2, crown reduce by no more than 2.0m in height and in lateral spread. Works recommended to reduce the risk of branches or stems breaking out when the tree comes into fruit.
- T4 Cherry tree situated along the RHS boundary, lift the lower section of the canopy to neaten and crown reduce in height by no more than 3.0m to contain and maintain the tree within it's space.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
