NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

IN GROUNDS (SEE PLAN): 1 x Maple (T2) - Crown lift canopy to 3.5m.

10 x Limes (G1) - Crown reduce height and spread to previous reduction points (approx. 1.5m height and 1m spread).

2 x Limes (G2) - Crown reduce height and spread to previous reduction points (approx. 1m height and 1m spread).

1 x Oak (T4) - Crown lift canopy to a height of 5m.

1 x Mimosa (T5) - Crown lift canopy 0.8m - 1m above the adjacent black metal railing.

1 x Sycamore (T6) - Reduce extremities growing towards building to give a clearance of 1.5m.

1 x Loquat (T7) - Reduce extremities growing towards building to give a clearance of 1.5m.

Remove two secondary stems growing to the West Reduce unruly spread to shape and balance (approx. 1m).

5 x Acacia (G8) - Reduce unruly height and spread (approx. 0.5m height and 0.3m spread).
Crown lift to a height of 2m. Crown thin by 15%.

1 x Large Hazel (T9) - Fell to ground level.

The Council has considered your notification of intended works to trees dated 07 February 2025 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
