T2 Eucalyptus Fell as close to ground level as possible. Works due to large cavity under bark at base and fungal growth.
H3 Leyland Cypress (right side of property) No works to height of hedge, only trim face of hedge on right side of the house as hard as possible to the fence line.
All works as part of regular maintenance. Eucalyptus Fell due to possible stability issues.
