Large Holly - Carry out a light general prune of the entire tree to improve form and shape (approx. 1m height and 0.5m spread)

Crown thin by 10%

Maintenance works in line with good arboricultural practice

Holly - Cut the entire tree to ground level

Sorbus - Cut to ground level

The owner wishes to re-landscape and will be planting 2-3 replacement trees. Trees will be chosen from the following species:

Betula utilis 'Jacquemontii'
Prunus x subhirtella 'Autumnalis Rosea'
Crataegus laevigata 'Paul's Scarlet'
Heptacodium miconoides
Malus 'Aros'
Malus 'Evereste'
Amelanchier lamarckii

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ~$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
