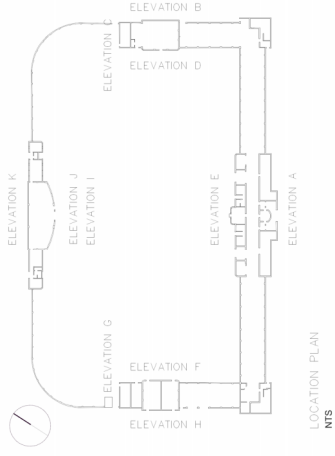


- 1. NOT FOR CONSTRUCTION.**
