Proposal:
(TPO REF: 20H-G1) FRONT GARDEN: 3 x Limes (T12, T13 & T14) - Crown lift to provide 3m clearance from ground level.
(TPO REF: 20H-G1) FRONT GARDEN: 1 x Lime (T14a) - Remove lowest SSW branch.
(TPO REF: 20H-G1) FRONT GARDEN: 1 x Sycamore (T31) - Reduce all aspects of the crown back to previous points of reduction by approx. 2m - 3m.
(TPO REF: 20H-G6) FRONT GARDEN: 1 x London Plane (T32) - Reduce all aspects of the crown back to previous points of reduction by approx. 3m - 4m.

The Council has considered your application dated 20 February 2025 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).
