Front Garden: T1 & T2: 2 x Limes: Approximately 8.00m. Reduce crown by approximately 1.25-1.50m all round. Remove epicormic growth on main stems.	
Remove basal epicormic growth as is practicable.	
Reason: General maintenance.	

T3: Dead Lilac: Fell to as near to ground level as is practicable.
