Birch (T1) - reduce crown by 2.5m on all aspects. The tree overhangs the pavement and road, and is almost as tall as the school building. The school would like to keep the tree at a manageable size, given the proximity to the building and public spaces. Birch x 3 (T2, T3, T4) - reduce height by 2.5m, to keep the trees low, as screening from the adjacent buildings and road.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
