

Form Structural Door Opening

Form 1006x2036mm high clear structural opening in 360mm thick masonry wall. Allow for all necessary temporary support.

Supply and build in over opening prestressed concrete lintels with 100mm min end bearings Allow for making good all disturbed plaster wall finishes, flooring, skirtings and decorations

60 min Fire Resisting Partitions

Supply and erect 125mm stud partitions consisting of 50x75mm S.W. studs @450mm max Ctrs faced with 2 layers 12.5mm Wallboard each side taped and jointed and sealed with all joints to door lining and floor. Allow for supply and fixing of all necessary pattress's.

60 min Fire Resisting Ceiling
Supply and construct fire resisting ceiling to WC consisting of 145x44mm ceiling joists @ 450mm Ctrs (2500mm FFL to U/S of joists). Supply and line underside of joists with 1 layer

12.5mm Wallboard taped and jointed. Supply and fix between joists and over the top of wallboard Envirograf 60 minutes (UF60) under floor fire barrier. Supply and fix on top of joists 22mm T&G chipboard or OSB 3 floor boarding

Suspended Ceiling (2300mm FFLto U/S of ceiling) Supply and install Armstrong Zentia Aruba 600x600mm

Ceiling Tiles with Prelude 24 TLS + Exposed 24mm Grid

Supply and fix 1No Certifire Accredited FD30s factory finished painted flush door sets (Door

Leaf 926x1980mm).)

1No Accessible WC Sign (metal)

Ironmongery to be satin stainless steel. Ironmongery to be Certifire Approved Ironmongery and must be compatible with the door manufacture for fire certification. All to be fitted by Q Mark Certified Installer or similar Third party Accreditation Installer

Pair and half double ball bearing butt hinges (3x Grade 13 fire door hinges per leaf) with intumescent pads 1No Disabled Toilet Handle Facility Indicator Bolt Set for hinged door Lockset Satin S/S

1No Finger Guard set - Lorient LAS9070 / LAS9050 Finger Guard kits Kick plates either side of door leaf 900x 200mm high Door Stop SKU 88201

Supply and lay new no-slip no-slip Polyflor Polysafe Vogue Ultra PUR Woodland Grey 4770 to Accessible WC . Allow for coved skirtings and link flooring to hygienic wall cladding.

Whiterock Wall Protection

Prepare walls and supply and install Altro Whiterock hygienic walling cladding system with welded joints linked to non slip flooring fixed to wallboard faced partitions and plastered walls. Colour. White to Accessible WC.

Sanitaryware

Supply and install 1No DOC M compliant set - Armitage Shanks Contour 21+ close coupled WC Doc M Pack (Grey) left handed handing.

Consisting of :-Close coupled WC pan (S305401) Close coupled lever voistern (S365401)

Seat only (S4066) Single tap hole wash basin (Right handed tap hole basin S247401)

Basin wall fixings (S911067) Strainer waste (S881001) Bottle trap (S891067)



Prepare and apply mist coat and two coats of Dulux Trade - White Diamond Matt Emulsion to new partitions WC partitions in RADA office

Apply mastic sealant at abutment with sanitaryware and whiterock wall cladding
