The proposal seeks to convert the existing basement-level conference room area of the Melia White House Hotel into a new swimming pool and spa facility for hotel guests. The intervention will be entirely internal and will not involve any excavation or structural alterations that impact the fabric of the listed building. As such, the historic and architectural significance of the building will be preserved.

The only external impact will be the installation of a small number of discreet air extraction grilles at ground floor level, positioned at street level. These will be carefully integrated to minimise visual and physical impact on the listed façade. Overall, the works aim to enhance the hotel's guest offering by introducing modern wellness facilities, all within the existing footprint of the building.
