Details of the pre-application advice received

The proposal involved altering a previously approved mansard-style roof extension so that the front and rear walls would be flush with the property's façade, effectively creating a full additional storey.

Camden Council advised that while the principle of a sensitively designed mansard-style roof extension was acceptable (as demonstrated by the planning permission granted in 2024), the revised proposal would not be supported. The planning officer emphasised particular concern with the proposed front elevation being flush with the main façade, noting that this would appear as an additional storey rather than a subservient roof extension. While the rear alignment was also noted, the design impact of the front wall alignment was considered especially problematic. Overall, the proposal was seen as bulky, dominant, and inconsistent with the prevailing character and form of neighbouring properties.

This approach would be contrary to Policy D1 of the Camden Local Plan, Policy D3 of the Kentish Town Neighbourhood Plan, and Paragraph 125(e) of the NPPF.

In terms of amenity, the proposed extension was not considered likely to result in harm through loss of light, outlook, or privacy to neighbouring properties. However, the design concerns — particularly with the front elevation — outweighed other considerations, and the Council indicated that the proposal in its current form would not be supported in a formal planning application.
