e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Holly (T1) – Fell multi-stemmed tree. It is now taking over half the width of the garden. Removal will allow for new planting. Sycamore (T2) – Remove the vertical limb over the garden, back to the main stem. The aim is to let more light into the garden, it is currently very shady.
