Unity champions working class voices and arts-based community initiatives.</p> <p>We believe the rejuvenation of the Saville would have an immeasurable effect on the local community by boosting the economy and creating much-needed jobs in the arts sector, helping to tackle the deprivation in Camden by offering free tickets and training programmes for local people.</p> <p>The organisation We Make Camden found in 2023 that the most deprived area in Camden, the Gospel Oak Ward, is among the 5% most deprived areas in England, and 1 in 3 children in Camden grow up below the poverty line.</p> <p>Figures set out in The State of the Arts, published by the Campaign for the Arts and The University of Warwick, reveal that the UK has one of the lowest levels of government spending on arts and culture among European countries, having slashed its total culture budget by 6% since 2010. Meanwhile, Germany increased its budget by 22%, France by 25% and Finland by 70%.</p> <p>Analysis of nearly one million listed events between 2018 and 2023 showed that there has been a 23% fall in the number of music, theatre, dance and comedy events being put on in the UK, and the BBC has seen its total public and grant funding decrease by 23%. Several theatres have lost government funding over the last few years including Birmingham Rep and Bristol Old Vic, leading to an increase in co-productions and thus fewer jobs.</p> <p>This has created a climate of elitism where arts jobs are becoming accessible only to those coming from a background of generational wealth; the Sutton Report (2024) found that 86% of classical musicians in the UK had attended a fee-paying school, as did 35% of BAFTA-nominated actors (the national average is 7%).</p> <p>For this reason, the rejuvenation of the Saville would also be a healthy, positive addition to the arts landscape in the UK, at a time when investment in the arts and jobs creation are desperately needed.</p> <p>Signed, Trustees of Unity Theatre Trust</p>
