Tree located at 67 Belsize Park Gardens

T1 London Plane, reduce lateral and vertical branches over garden by 2 M approx back into most recent previous pruning points to reduce weight bearing load over garden, without causing any adverse effect to the balance and future growth of the tree. Remove dead branches.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
