T2 - Cherry - Fell. Decay is developing at a significant pruning wound 1.5m above ground level. This tree also has a very sparse canopy with dead wood throughout and is in decline. Consequently, we do not consider this tree to be worthy of special protection.

T3 - Sycamore - Fell. The stem of this tree is pressed against the rear boundary fence and concrete foundation; consequently, it is considered to have a reduced life expectancy. In addition, this tree has been crown-reduced and is not considered to have a particularly high amenity value. Consequently, we do not consider this tree to be worthy of special protection.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
