Why do you consider that a Lawful Development Certificate should be granted for this proposal?

In accordance with Part 14 of Schedule 2 of The Town and Country Planning (General Permitted Development) (England) Order 2015, installation of solar PV or solar thermal equipment is considered permitted development, provided it does not extend beyond 0.6m of the highest part of the roof when placed on a flat roof (Class A.1(ba)), and is sited, so far as practicable, to minimise its effect on the external appearance of the building.

There are no Article 4 directions revoking permitted development rights to the site.

Since the proposed solar panels are sighted to the rear of the property, away from the principal elevations, and do not protrude beyond the highest part of the existing roof (and thereby below the 0.6m threshold), the proposal is deemed lawful under The Town and Country Planning (General Permitted Development) (England) Order 2015.
