PART OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A
CONSERVATION AREA

Proposal:

REAR GARDEN: 1 x Fir (T1) - Reduce height by approx. 4m.

1 x Bay (T2) - Lift crown by approx. 2m on NE side and 1m on SW side and remove basal shoots from base of tree.

The Council has considered your notification of intended works to trees dated 11 March 2025 and decided to **OBJECT** to the following work:

REAR GARDEN: 1 x Fir (T1) - Reduce height by approx. 4m.

Reasons for objection:

A reasonably large fir tree in the rear garden which has relatively high visibility across the sports ground and from along Alvanley Gardens making a positive contribution to visual amenity. The proposed 4m reduction would have a significant impact on the future form of the tree removing the leader and altering the growth shape. The tree would currently appear to be in good form and health, no reasons have been given in support of the proposed works.

A Tree Preservation Order has been served on the tree/s and no work should be carried out without the prior consent of the Council.

However, the Council would not have any objection to the carrying out of the following works:

REAR GARDEN: 1 x Bay (T2) - Lift crown by approx. 2m on NE side and 1m on SW side and remove basal shoots from base of tree.
