Proposed Work:

ST MARK'S BRIDGE: 1 x Elm (Ulmus sp.) (LZ01168) - Prune out branch on adjacent elm rubbing this tree's stem at 2m.

1 x Field Maple (Acer campestre) (LZ01172) - Coppice.

1 x Field Maple (Acer campestre) (LZ01179) - Coppice.

CAR PARK PUMP STATION: 1 x Sycamore (Acer pseudoplatanus) (LZ0083) - Fell to ground level.

1 x Hawthorn (Crataegus sp.) (LZ03364) - Crown lift to 2m. Remove epicormics on trunk and at base.

1 x Hawthorn (Crataegus sp.) (LZ03581) - Fell to ground level.

The Council has considered your notification of intended works to trees dated 28 March 2025 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.

- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
