The proposed extension and alterations will have no impact on existing trees and planting and are below the LB Camden de minimis threshold for BNG assessment. The extension and patio will align with the neighbouring patio line and will have no impact on neighbouring gardens and amenity. The proposals represent a substantial improvement to the current garden area and planting with new shrubs and planting to the existing border beds and additional space for pots and planters on the lower patio. The existing small garden is currently entirely paved over with narrow raised planting beds to the rear wall and along one side. These beds will be retained and existing shrubs maintained providing both a biodiversity resource and privacy hedging between gardens.
