Rear Boundary: T1 & T2: 2 x Sugar Maples: Approximately 12 00m-13 00m: Reduce both trees hard back to previous and most recent reduction points

T1 & T2: 2 x Sugar Maples: Approximately 12.00m-13.00m: Reduce both trees hard back to previous and most recent reduction points approximately 3.50m. Control encroachment from rear boundary of No.7 Reddington Road.

H1: Yew Hedge: Approximately 5.00m: Rear boundary: Reduce height by approximately 1.20m. Reduce lateral and sub lateral growth overhanging No.7 by approximately 0.50m. To control encroachment.
