Rear of No.10 Jeffreys street (over hanging No.8):

T1: Magnolia Grandiflora: Approximately 7.00m: Fell to as near ground level as practicable. Group of 3 x trees, Magnolia in No.8 and Magnolia and Willow in No.10 are planted very close together. The gardens are now quite overcrowded and encroaching the wall. Control encroachment and possible hazard.

T2: Willow: Approximately 7.00m: (No.10): Reduce back to previous and most recent reduction/pollard points.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
