Proposal:
(TPO REF: H5-T120) REAR GARDEN: 1 x Horse Chestnut (T1) - Reduce away from neighbouring property (1 Greencroft Gardens) by up to 1m to provide 2m clearance. Crown lift up to 3.5m height over pavement and road to provide clearance for pedestrians and vehicles. Remove any defective branch wood.

The Council has considered your application dated 22 April 2025 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.
