## Proposal:

Replacement of timber windows and doors with double glazed timber units to the front and rear elevations.

The Council has considered your application and decided to grant permission subject to the following condition(s):

#### Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

The development hereby permitted shall be carried out in accordance with the following approved plans: Site Location Plan; PL201.P2; PL202; PL301; PL401.P2; Window Section (Rear Sash Windows); Window Section (Rear Casement Windows); Window Section (Front); Stained Glass Sash Section; Stained Glass Casement Section; Design and Access Statement P3 (Revised) dated 14/05/2025.

Reason: For the avoidance of doubt and in the interest of proper planning.

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies D1 and D2 of the London Borough of Camden Local Plan 2017.

# Informative(s):

1 Reasons for granting permission.

The property is a three-storey plus basement terraced house built in the 1880s, with period architectural details such as bay and sash windows. It is also located within the Mansfield Conservation Area.

The existing timber windows and doors would be replaced with double glazed equivalents to the front and rear elevations.

A revision was received to retain the leaded lights and coloured glazing of the windows on the front elevation as those are considered significant architectural features of the building. The stained glass would be carefully removed and installed into the new window frame with the double glazing behind it, retaining the external appearance of the stained glass. The front door design would also be retained.

These replacement windows and doors would match as closely as possible the existing windows and doors in terms of materials, colour, frame sizes, opening methods and proportions. The only difference would be the design of three of the rear windows (marked as W09 and W10 on the proposed west elevation drawing) and the rear exit door (D03). Those windows would no longer include glazing bars. The rear exit door would not be replaced like for like however it would remain in timber and traditional looking so is acceptable.

There would be some degree of increased thickness to the frames in order to accommodate the double glazing panes; however, in this instance, the use of suitably designed slim-line units to the front are considered to be an appropriate and sympathetic change unlikely to alter or detract from the character and appearance of the host building and wider Mansfield Conservation Area.

There are no amenity concerns to neighbouring properties given the proposal

would replace existing building features and fenestration.

The site's planning and appeals history has been taken into account when coming to this decision. The Mansfield CAAC was consulted but did not comment.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the Mansfield Conservation Area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act [ERR] 2013.

As such, the proposal is in general accordance with policies A1, CC1, D1 and D2 of the Camden Local Plan 2017, the London Plan 2021 and the National Planning Policy Framework 2024.

Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must secure the approval of the Council's Noise and Licensing Enforcement Team prior to undertaking such activities outside these hours.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with the National Planning Policy Framework.
