Crown reduce by approximately 3.0 metres laterally and reduce in height to balance to create a 2.0 metre clearance from the clients property and the neighbouring property. Remove deadwood and remove all hanging branches.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
