T3 - dead ceanothus tree (3m) - take down to ground level.
T4 - ceanothus tree (8m) - reduce Right hand limb over rear wall by approximately 4m.
T5 - cedar tree (8m) - reduce overhanging branches from ground level with pole pruners by up to 2m.
