Proposal:

Display of 6 window vinyls applied to the glazing to cover ground floor windows during internal fit out from May to July 2025.

The Council has considered your application and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

1 No advertisement is to be displayed without the permission of the owner of the site or any other person with an interest in the site entitled to grant permission.

Reason: - As required by regulation 2(1) and Schedule 2 of the Town & Country Planning (Control of Advertisements) (England) Regulations 2007.

- 2 No advertisement shall be sited or displayed so as to
 - (a) endanger persons using any highway, railway, waterway, dock, harbour or aerodrome (civil or military):
 - (b) obscure, or hinder the ready interpretation of any traffic sign, railway signal or aid to navigation by water or air; or

(c) hinder the operation of any device used for the purpose of security or surveillance or for measuring the speed of any vehicle

Reason: - As required by regulation 2(1) and Schedule 2 of the Town & Country Planning (Control of Advertisements) (England) Regulations 2007.

3 Any advertisement displayed and any site used for the display of advertisements, shall be maintained in a condition that does not impair the visual amenity of the site.

Reason: - As required by regulation 2(1) and Schedule 2 of the Town & Country Planning (Control of Advertisements) (England) Regulations 2007.

4 Any structure or hoarding erected or used principally for the purpose of displaying advertisements shall be maintained in a safe condition.

Reason: - As required by regulation 2(1) and Schedule 2 of the Town & Country Planning (Control of Advertisements) (England) Regulations 2007.

Where an advertisement is required under these Regulations to be removed, the site shall be left in a condition that does not endanger the public or impair visual amenity.

Reason: - As required by regulation 2(1) and Schedule 2 of the Town & Country Planning (Control of Advertisements) (England) Regulations 2007.

The vinyls hereby permitted shall be displayed for a temporary period only and shall be removed on or before 31/07/2025.

Reason: - This type of advert is not such as the Council is prepared to approve, other than for a limited period, in view of its appearance. Its permanent display would be contrary to the requirements of policies D1, D2 and D4 of the Camden Local Plan 2017.

Informative(s):

1 Reasons for granting consent-

The proposal includes the display of 6 window vinyls on the ground floor glazed windows during the internal fit out works that are taking place between May to July 2025 associated with a forthcoming live experience run by The Everywhere Group to open the Traitors Immersive Experience in July 2025. The vinyls would display writing and images relating to the experience.

The scale and size of the vinyls are not something that would normally be supported on a permanent basis as they would dominate the ground floor elevation leaving no glazing surrounding the vinyls which could lead to a dead frontage. As the vinyls would only be displayed for a temporary period of 3 months and would be removed at the end of July 2025 they would not be considered to have any long lasting harm and would not be considered to detract from the overall appearance of the building nor impact on the wider conservation area. Under these particular

circumstances, a condition would be attached to any approval to ensure that the vinyls hereby permitted are removed in a timely fashion.

The vinyls, given their scale, size and siting, would not impact on public safety nor causes hazards to highway users.

The proposal is not considered to cause any adverse impacts on the amenity of adjoining residential occupiers.

No objections have been received prior to making this decision. The planning history of the site has been taken into account when coming to this decision.

As such, the proposed development is in general accordance with policies A1, D1, D2 and D4 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2021 and the National Planning Policy Framework 2024.

Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You must secure the approval of the Council's Noise and Licensing Enforcement Team prior to undertaking such activities outside these hours.

Please be advised that the use of the basement and ground floors as an immersive experience venue does not benefit from the necessary planning permission. Change of use of a building without the benefit of planning permission can result in enforcement action being taken. The granting of advert consent for vinyls associated with this event should not be taken as the local planning authority either supporting or opposing this use.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with the National Planning Policy Framework.
