Proposed Work:

REAR GARDEN: 1 x Bay (T1) - Reduce canopy to previous levels (3m in height and 1m in lateral spread), balance and shape.

1 x Holly (T1a) - Shape to balance same as Bay (T1) .

1 x Bay (T2) - Reduce canopy to previous levels (3m in height and 1m in lateral spread), balance and shape.

1 x Apple (T3) - Reduce canopy to previous points (2m in height and 1m in lateral spread).

1 x Apple (T4) - Reduce canopy to previous points (2m in height and 1m in lateral spread).

1 x Acacia (T5) - Thin canopy density by 30% and remove crossing branches.

1 x Plum (T6) - Reduce canopy by 1m in height and balance sides to shape.

The Council has considered your notification of intended works to trees dated 25 March 2025 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS

3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
