T1: Ash – crown reduce by 2-3m back to previous pruning points, remove deadwood >30mm, carry out aerial inspection.
Part of ongoing cyclical pruning regime to limit shade and leaf litter and to reduce over loading on regrowth points.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
