My client would like to reduce 1x Robina back to previous points to suitable growth points, by removing up to 2m branch length. The reason is to maintain the size in relation to the space, and keep the tree from growing too close to the two buildings.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
