Details of the pre-application advice received

Planning permission refused for installing fall arrest protection railings, extract fan flues (to front and rear elevations) and flat roof insulation. Advised subsequently that the extract fans terminating on street facing elevations was considered harmful to character and appearance of building and appearance of Conservation Area and that the railings were also unacceptable (despite consent being obtained on properties in close proximity a couple of years prior). Advised that the roof insulation could be considered in isolation and that extract fan louvres would require planning permission to the rear elevations, again despite advise being obtained from another planning officer that such alterations would not require planning permission to rear facing elevations as the works were considered de minimis.
