Rear Garden:

G1: Row of Mature Leyland Cypress: Approximately 12.00m. Reduce height by approximately 4.00-5.00m. Reduce lateral and sub lateral growth over No.55 by up to 2.00m as is practicable.

Reason: General maintenance to increase light levels.

T1: Mature Yew - (adjacent to the shed): Approximately 8.00m. Raise crown by up to 1.20-1.50m. Reduce crown by 1.20-1.50m all round to produce a more compact balanced crown.

Reason: General maintenance and to provide clearance for a new pergola.

T2: Mature Willow: Approximately 7.00-8.00m. Reduce over long branches by up to 1.50m back into the main crown structure. Thin crown density by 20%.

Remove major dead wood throughout crown.

Reason: General maintenance.

Front Garden:

T3: Mature Thorn: Approximately 7.00m. Fell to ground level and treat stump with systemic herbicide.

Reason: The tree is very close to the buildings and the front garden is crowded with large specimen trees.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
