Tree of Heaven in the front of the property.  Dead branches, mostly on northeast side close to the building. Remove dead branches.
Branches growing over the top fo the public pavement, raise to 2.5m.  Reduce lower branches on south side over car park by approx 2m to alliviate weight and bring into shape with the rest of the tree. This should
also raise the crown to approx 3m.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).
