a) Plan, elevation and section drawings of new railings and balcony at a scale of 1:10 including materials, finish and method of fixing.

b) Plan, elevation and section drawings of all new windows and external door at a scale of 1:10 with typical glazing bar details at 1:1.

The relevant part of the works shall then be carried in accordance with the approved details

2 The works hereby approved are only those specifically indicated on the drawing(s) referred to above.

3 All new external and internal works and finishes and works of making good to the retained fabric, shall match the existing adjacent work with regard to the methods used and to material, colour, texture and profile, unless shown otherwise on the drawings or other documentation hereby approved or required by any condition(s) attached to this consent.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP25 of the London Borough of Camden Local Development Framework Development Policies.

4 All new work and work of making good shall be carried out to match the original work as closely as possible in materials and detailed execution.
