Rear Garden - Willow -(Aprox. 17m): Reduce crown by aprox. 25-30% cutting extraneous growth back to suitable growth points within main crown. Thin crown by 20%. Remove dead wood/broken branches. Reason - maintenance and repeat work.  
Front Garden - Large Fig - (Aprox. 11-12m): Remove two leaning stems, one over the road and one over the drive. Thin remaining crown by 20% and reduce to clear building by 0.5m. Reasons - to help abate nuisance to traffic whilst preserving aesthetic value.  
2 x Robinia Frisia: Pollard/reduce by 50%. Reasons - Two of the original four trees have previously collapsed, they show signs of decay and the crowns are structurally unsound and located over footway.
